The Department of Housing and Urban Development (HUD) issued NOTICE PIH 2020-05 on April 10, 2020. This notice remains in effect until amended, superseded or rescinded. Pursuant to the authority provided under the CARES Act, HUD is waiving and establishing alternative requirements for numerous statutory and regulatory requirements for the Public Housing program and Housing Choice Voucher (HCV) program. These waivers provide administrative flexibilities and relief to Bloomington Housing Authority in response to the COVID-19 national emergency.

**UPDATE:** The Summary of Adopted Waivers has been updated in accordance with Notice PIH 2020-13, issued July 2, 2020.

Concern Inspections	<ul style="list-style-type: none"><li>• Allows BHA to postpone inspections and rely on alternative methods such as self-certification to ensure unit meets Housing Quality Standards</li></ul>	<ul style="list-style-type: none"><li>• 12/31/20</li></ul>	YES	4/17/20
